Provides for the consideration of the Senate amendment to H. Makes in order a motion offered by the chair of the Committee on the Judiciary or his designee that the House concur in the Senate amendment to H. Waives all points of order against consideration of the motion. Provides that the Senate amendment and the motion shall be considered as read. Provides one hour of debate on the motion equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary. Structured rule for H. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Transportation and Infrastructure. Waives all points of order against consideration of the bill. Each such amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question. Waives all points of order against the amendments printed in the report. Provides one motion to recommit with or without instructions. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations. Provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print , shall be considered as adopted and the bill, as amended, shall be considered as read. Waives points of order against provisions in the bill, as amended, for failure to comply with clause 2 rule XXI, except beginning on page 66, line 14, through page 66, line Makes in order only those further amendments printed in part B of the Rules Committee report. Each such amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, may be withdrawn by the proponent at any time before action thereon, shall not be subject to amendment, and shall not be subject to a demand for division of the question. Provides that no further consideration of the bill shall be in order except pursuant to a subsequent order of the House. Provides that the chair and ranking minority member of the Committee on Appropriations or their respective designees may offer up to 10 pro forma amendments each at any point for the purpose of debate. Provides that during consideration of H. Amendments click headers to sort.
